What type of information do I collect?

Via the Life by Ms. Lewis subscription, I receive, collect and store any information you enter on my website or provide me in any other way. In addition, I collect the Internet protocol (IP) address used to connect your computer to the Internet; login; e-mail address; password; computer and connection information and purchase history. We may use software tools to measure and collect session information, including page response times, length of visits to certain pages, page interaction information, and methods used to browse away from the page. We also collect personally identifiable information (including name, email, communications). I may also collect comments, feedback, product reviews, recommendations, and personal profile.

How do you collect information?

When you join my website, as part of the process, I collect personal information you give us such as your name, address and email address. Your personal information will be used for the specific reasons stated above only.

Why do I collect such personal information?

I collect such Non-personal and Personal Information for the following purposes:

- To provide my Users with ongoing updates relevant to my blog;
- To be able to contact my Visitors and Users with general or personalized service-related notices and promotional messages;
- To comply with any applicable laws and regulations.

How do I store, use, share and disclose your information?

The Life by Ms. Lewis blog site is hosted on the Wix.com platform. Wix.com provides us with the online platform that allows us to share updates and relevant marketing or information.. Your data may be stored through Wix.com's data storage, databases and the general Wix.com applications. They store your data on secure servers behind a firewall.

All direct payment gateways offered by Wix.com and used by our company adhere to the standards set by PCI-DSS as managed by the PCI Security Standards Council, which is a joint effort of brands like Visa, MasterCard, American Express and Discover. PCI-DSS requirements help ensure the secure handling of credit card information by our store and its service providers.
